# Recognizing the Need for Medicaid Spending Reform Bethesda Residents Participate in Activities to Promote Change

On the afternoon of April 4, **Shirley Witcher** climbed aboard the bus and took her seat, weary yet satisfied after completing a "job well done."

Shirley, along with 34 fellow Bethesda residents and staff, had spent the day at the State Capitol in Jefferson City, meeting with legislators and encouraging them to address the current gap in the Missouri budget for Medicaid reimbursement.

"We are encouraging the legislators to 'Bridge the Gap' and allocate more money in the budget to Medicaid spending for seniors," said Shirley.

Residents representing six
Bethesda communities
attended the trip, coordinated
by Leadership Team members
Chris Crouch, Nathan Torno and
Michelle Glass. On the bus,
the residents received talking
points and a flyer outlining the

disparity between what Missouri's formula has promised to provide for Medicaid spending and the actual figures.

After a lunch session with State Senator **Scott Sifton**, whose area of coverage includes most Bethesda communities, the group took to the Capitol hallways. Clad in their vibrant orange "Bridge the Gap" T-shirts, the residents met with legislators and their staffs to share their thoughts and concerns.

Bethesda Terrace residents and staff met with State Representative Marsha Haefner. A group met with State Senator Jill Schupp.
Other groups discussed issues with the staff representatives of State Senators Bob Onder and Jamilah Nasheed.

As for Shirley, a Bethesda Gardens resident, she received a warm welcome from an old friend.

"Years ago, I needed physical therapy, and was referred to a

therapist named **Deb Lavender**," Shirley said. "During my therapy, I got to know her as a person as well as a therapist. When Deb announced that she was going to run for office, I knew I had to help out."

"Shirley may have been my very first volunteer," said Lavender, who is now a State Rep. An advocate for Medicaid budget reform, she took the time to meet with multiple groups from Bethesda.

Bethesda has been involved in many activities in conjunction with trying to affect Medicaid spending reform. **Joe Brinker**, Bethesda's President & CEO, wrote an "oped" piece that ran in the April 20 edition of the *St. Louis Post-Dispatch*.

## Veteran Escort Ceremony— An Honor for Those Who Served

At Bethesda, respect for life is the top priority. Now a new program in its communities honors military Veterans in death as well.

Coordinated by **Leslie Schaeffer**, Outreach Coordinator with Bethesda Hospice Care, the Veteran Escort Ceremony is observed at all Bethesda skilled nursing communities.

When a Veteran dies and the funeral staff has prepared the body for transport, the gurney is covered in an American flag. An announcement is made that a procession will begin. Employees, family members, volunteers and residents (who are able) line the hallways and salute the passing of the body. Family members and Veteran volunteers walk beside the Veteran as the gurney makes its way to the front door, at which time the flag is removed and folded according to military procedure.

"Family members tell us they feel blessed and honored to be a part of the program," Leslie says. "They are so grateful for the way we pay tribute to their Veteran loved one."



According to Leslie, the idea developed from "We Honor Veterans," an initiative in which Bethesda Hospice Care is at the top level. "We take pride in meeting the unique needs of Veterans, listening to their military experiences, and acknowledging and honoring their military service," she says.

She believes that Bethesda's Veteran Escort Ceremony is unique to skilled nursing communities in the St. Louis area. The innovative program was presented to the Missouri Hospice and Palliative Care Association's 2018 Leadership Development Seminar in Jefferson City earlier this year.

Future plans include a similar observation for all Bethesda residents.


At the Women's Board luncheon,
