Bethesda Exceeds National Standards in Staffing Ratings

Bethesda Health Group has earned some very impressive ratings in the Centers for Medicare and Medicaid Services (CMS) Five-Star Rating System, especially in the area of staffing.

The system, which began posting ratings in 2008, is designed to help consumers and families compare quality among skilled nursing communities on a state-by-state basis.

The overall rating given to a skilled nursing community is based on three measures:

- health inspections ratings that assess data from the last three years of onsite inspections
- a staffing rating encompassing the number of hours of care provided on average to each resident every day
- quality measures on physical and clinical measures for residents.

Each measure has its own five-star rating component.

According to **Kiel Peregrin**, Corporate Vice President, Long Term Care, **all six Bethesda skilled nursing communities have exceeded the norm by scoring at least a 4, if not a 5, in the staffing measure in recent CMS reports.** The average national rating is three stars.

The CMS target number for skilled nursing communities receiving this highest rating is just 10%, but Kiel says CMS "raises the bar every year" in terms of standards, making the Bethesda result that much more impressive.

The measures have a direct bearing on care. Kiel points out that sufficient staffing, for example, reduces medical errors, resident complications and mortality. "It also shortens the time it takes to provide care, because an adequate number of staff are available to attend to the needs of the resident," Kiel says. According to Kiel, the high CMS ratings for Bethesda are a result of Quality Assurance and Performance Improvement meetings, which are held monthly at each Bethesda skilled nursing community. At these meetings, an interdisciplinary team comprised of the Administrator, Medical Director, Director of Nursing, pharmacy consultant, dietitian, and other department leaders address the current needs at that specific community.

"The exemplary staffing rating coincides with the Bethesda mission, which is to be the premier provider of care and services for seniors," Kiel says.

New Budget Reflects Increases in Medicaid Reimbursement for Senior Organizations

During the last few months, Missouri legislators received numerous phone calls, text messages and emails, urging them to vote to "Bridge the Gap" and increase the Medicaid reimbursement provided to senior care and service organizations.

Many of those contacts were part of a concentrated campaign coordinated through LeadingAge Missouri and involved senior organizations across the state, including employees and residents from Bethesda.

On June 29, Missouri Governor Mike Parson approved the budget for Fiscal Year 2019, which reflected increases to Medicaid reimbursement for seniors:

• an increase of \$8.30 per day for skilled nursing patients

and residents (a \$25 million budget increase for the state of Missouri)

• the restoration of half of the previous year's budget cut for Home and Community Based Services' Medicaid providers (a 1.5% budget increase)

"This is wonderful news, but our work in this effort must continue," says **Joe Brinker**, Bethesda President and CEO. "Even with the increases, Missouri remains among the lowest in the country in state budget allocations for senior Medicaid reimbursement. Once the legislature begins addressing the allocations to the Fiscal 2020 Missouri budget, the campaign for additional reform will begin."

2018 Tax Savings Using Your IRA

The government requires U.S. citizens aged 70½ or older who have a traditional IRA account to withdraw a minimum amount, called a required minimum distribution (RMD), and pay income taxes on it every year.

This amount could be excluded from a taxpayer's taxable income if paid directly to charity.

Gifting all or a portion of an RMD can be a very beneficial taxsavings strategy for many seniors, especially for those who do not itemize deductions. Instead of writing a check, transferring securities or using a credit card for charitable giving, many seniors are using their IRAs to serve as a charitable donation.

Individuals may gift a charity up to \$100,000 annually from an IRA; the money is "counted" as the RMD but is not included in the adjusted gross income. The one requirement—the funds must come directly from your IRA to a qualified charity.

To make a generous gift to Bethesda using your IRA, contact the Foundation or your financial advisor, who can help you make sure that the financial institution executes the transfer correctly.
